Current Approved Auditors

All GDL refiners and applicants must use an auditor on LBMA's Approved Service Provider List. The List is regularly reviewed and maintained up to date. Auditors are required to demonstrate fulfilment of the requirements detailed in LBMA's [Responsible Sourcing: Third Party Audit Guidance](#).

Below are the contact details for auditors on the Approved Service Provider List, as well as information on the geographic remit (global; regional; national) and the scope of engagement they are approved to audit. Auditors are approved to carry out third-party audits for GDL refiners based on the ISAE 3000 Standard.¹

Applications

Entities interested in being listed as an Approved Service Provider, must submit an application form available on LBMA's website to mail@lbma.org.uk. We will email the main contact who submitted the application to let them know the outcome. If you are successful, the title of your auditing body and main contact's details will be added to our Approved Service Provider list. The process can take up to eight weeks from receipt of application.

International Branches

Please note that for the global audit firms listed (such as Deloitte, EY, KPMG or PwC), each international branch needs to be approved as an auditor separately. Each branch not listed as an auditor ("Non-Listed Branch") will need to submit a separate application form, or alternatively, the Non-Listed Branch will need to have all their audits approved by a listed branch (listed branch refers to a branch approved as an auditor). However, we request that you initially approach the listed contact under each institution so that they may assist their colleagues directly.

Fees

Auditors are subsequently required to pay an annual maintenance fee of £2,000 to be listed as an Approved Service Provider. Failure to pay your invoice within a reasonable time period may affect your listing as an Approved Service Provider.
